Client further agrees that it will not place stalls, booths, framework, lighting, or other structures closer than one (1) foot to tent top or tent walls under any circumstances, nor will Client attach signs or banners to tent top, valance, or walls of tent, nor will Client place nails, screws, staples, or bolts in tent poles.  Client agrees that the price set forth on the rental contract is based on the representation of the Client that the texture of the premises is adequate and suitable to securely hold stakes for guying tents.
